5. LEARNING OUTCOMES

- 1. To provide a good understanding of the manufacturing processes for different materials
- 2. To teach the basic tools for numerical control programming and simulation
- 3. To provide hands-on experience with operating CNC machines, injection molding and thermoforming machines, and rapid prototyping printers used in manufacturing processes
- 4. To demonstrate the use of CAD/CAM tools and how it integrates with machining principals
- 5. To supply the mathematical background for calculating the parameters for metal removal rates in manufacturing processes
- 6. To introduce composite manufacturing production and machining techniques
- 7. To describe classical and modern measurement technologies used in quality assurance
- 8. To introduce the fundaments of plant asset management
- 9. To help students understand the importance of reliability in manufacturing

AUTHENTICITY / PLAGIARISM DETECTION
