## 1. COURSE OBJECTIVES

At the end of the course, the students will have solid understanding of fundamentals of water chemistry and its applications as environmental engineers. The students will also practice and obtain relevant skills and techniques for determining water quality parameters

## 2. COURSE SPECIFIC POLICIES

**Attendance:** Lecture attendance is expected but will not be reflected in grading. It is strongly recommended that the students should not miss any lectures. Instructor's written notes will not be shared while power point presentations and handouts will be posted on Avenue to Learn.

**Textbook and course materials:** There are no designated textbooks in this course. In case you are interested in water quality engineering, you can read 'Water chemistry' by Snoeyink and Jenkins. Course materials will be posted on A2L.

**Examinations:** The McMaster Standard Calculator may be used during examinations. You may bring 1 crib sheet (letter size; double sided) in mid-term exam; and 2 sheets for the final examination.

- Crib sheets must be prepared only by hands (hand-written or hand-drawn contents only).

- Photocopied or printed information of any size is NOT allowed.

- Photocopies of your own handwriting (e.g., homework assignments and note) are NOT allowed.

**Assignments:** 3 homework assignments will be posted on A2L. Late assignments will be assessed a penalty of 20% per academic day in general; however, late assignments may not be accepted depending on course schedule.

**Laboratory experiments and term project:** Each student must participate in mandatory laboratory sessions, which will provide supplemental exposure to several important concepts that are covered in this course. We will have four regular lab sessions in addition to a preliminary lab. The dates for lab sessions are available on the Avenue calendar. Lab experiments will be conducted in groups of four students. All group members must participate in all labs. All group members are expected to take part in report/presentation preparation. Expected formats and structure of report/presentation will be posted on Avenue. A late penalty of 20% per academic day will be applied. All group members must read the lab handout prior to a lab session. There may be pre-lab

quizzes to ensure that you have read the lab handouts and understand experimental steps and materials. Both of the lab report and quiz will be included in your term project evaluation. During the preliminary lab session, we will have a safety presentation and group assignment. Attendance at this preliminary lab is also mandatory.

**Tutorials and term projects:** Detailed plans and contents on 3 term projects will be provided and discussed in tutorials while you need to obtain water quality information during the lab sessions. We will have final presentations for Project#3 during the tutorial sessions on [March 21, 24, 28, 31, April 4, 7]. We do not have tutorials every week, but we may have both tutorials and labs in a week. The tutorial dates will be announced on Avenue.

**MSAF Policy:** When a self-reporting relief is submitted, the portion of the missed academic work will be automatically transferred to the final examination. It is your responsibility to notify the instructor of your MSAF submission. For a group assignment (including lab attendance, term project reports/presentations), MSAF will NOT be accepted.

When this course is complete, the student will be able to:

- Use the fundamental knowledge on equilibrium, acid/base chemistry, stripping/dissolution chemistry, chemical precipitation, and complex chemistry. (1.2)
- Use the fundamental knowledge on microbiology, redox chemistry, mass balance, thermodynamics, kinetics, gas transfer, and nitrogen- and phosphorus-cycles. (1.2)
- Use relevant engineering tools and assumptions (e.g., logC-pH diagram, colony forming units) to analyze environmental engineering problems (e.g., chemical and biological water quality parameters). (2.1)
- Apply stoichiometry, reaction kinetics, material balances and reactor theory to develop mathematical models of contaminants moving through complex environmental systems, including rivers, estuaries, lakes, reservoirs and groundwater systems. (2.1)
- Work as a team to conduct laboratory experiments (e.g., quantification of various physical, chemical and biological water quality parameters for given water samples). (6.1)
- Work as a team to discuss the experimental results, draw conclusions, and provide engineering consulting services. (6.1)
- Give oral presentations for engineering clients (e.g., drinking water treatment facility) (7.3)
