Course Description: Application of the laws of conduction, convection, and radiation to problems in heat transfer. Steady and transient conduction in solids. Laminar and turbulent convection. Radiation heat transfer processes. Boiling and condensation heat transfer. Three lectures, one tutorial; second term Prerequisite(s): MATH 2M03 (or 2M06), or MATH 2Z03; and
