CALENDAR/COURSE DESCRIPTION

The purpose of this course is to introduce you to the following: (1) Derivation of mathematical <u>models</u> using ordinary differential equations and Laplace transforms. (2) <u>Analysis</u> of single input/single output systems and their components. This analysis includes a consideration of the system's time response, frequency response and stability characteristics. (3) <u>Design</u> of controllers for single input single output systems that meet design requirements, using root locus and frequency response techniques.

COURSE INTENDED LEARNING OUTCOMES

By the end of this course, students should be able to:

- 1. describe control systems using accurate terminology;
- 2. understand the advantages associated with a closed loop control system;
- 3. model a control system in both the Laplace domain and state space representations;
- 4. make reasonable assumptions to simplify a complex control system.
- 5. assess the stability of a control system;
- 6. assess the steady state errors associated with a particular control system;
- 7. design a controller using root locus techniques;
- 8. design a controller using frequency response techniques; and
- 9. make design recommendations that will improve system performance.
